By attachment of his/her signature, the applicant affirms that he/she and all individuals required to be identified in this application have never been convicted of a felony or a Class A misdemeanor and are not disqualified to receive a liquor license by reason of any matter or thing contained in the laws of the State of Illinois or the provisions of the Liquor Control Ordinance of the Village of Villa Park. The applicant and all individuals required to be identified in this application has not received or borrowed, and will not receive or borrow, money or anything else of value (other than merchandising credit in the ordinary course of business) directly or indirectly from any manufacturer, importing distributor, or distributor, nor has the applicant or other individuals required to be identified in this application been a party in any way, directly or indirectly, to any violation by a manufacturer, distributor, or importing distributor of any liquor law. The applicant and all individuals required to be identified in this application acknowledge that the granting of a liquor license is a matter of privilege and not a right; that citizens of the Village of Villa Park have traditionally and customarily enjoyed and professed a high regard for decency and morality; and that certain displays and activities are prohibited with the sale of alcoholic liquor as set forth in the Liquor Control Ordinance of the Village of Villa Park.
